<b>5. <u>Fire fighting measures</u></b>	Not explosive. Not auto-flammable. Not flammable (high water content in product). The product itself will not burn. If anything, packaging may be involved in a fire. Use CO <sub>2</sub> , dry chemical powders or alcohol resistant foam. If water is used, contain run-off.
